Since the beginning of the pandemic, our local organizations have been on the front line and have dealt with the impact of COVID-19 on their activities and community services. To support them, the federal government launched the Emergency Community Support Fund (ECSF) so that organizations could adapt their services to meet the needs of vulnerable people. This support has been of great benefit to our region.

With representatives from Centraide Estrie and the Estrie Community Foundation, I was proud to recently announce that the ECSF has funded 69 projects in the Eastern Townships for a total of over \$1.3 million. Thanks to this funding, cultural, community and educational organizations have been able to continue helping our community in this difficult time.

Right here in our Compton-Stanstead community, 13 organizations benefited from the ECSF for a total of over \$210,000. Help for the elderly, mental health support or even assistance with basic needs, our local organizations are there!

## RE-OPENING OF THE SERVICE CANADA BRANCH OFFICES IN COATICOOK AND MAGOG

Service Canada centres are gradually re-opening their doors for essential services involving Employment Insurance, the Canada Pension Plan, Old Age Security, as well as issues concerning social insurance numbers and passports for mandatory travel.

The Service Canada offices in Coaticook and Magog will be open starting mid-September. A Service Canada agent will be in contact with you within two business days.

#### **NEW POLICY ON TEMPORARY WORK PERMIT**

The Government of Canada has announced a temporary policy change that will support Canadian employers who are still struggling to find the workers they need and will also help temporary workers looking for work as Canada recovers from the pandemic.

Visitors who are currently in Canada and have a valid job offer will now be able to apply for a special work permit linked to their future employer and, if approved, receive the permit without having to leave the country.

To be accepted, an applicant must:

- Have valid visitor status in Canada on the day of their request;
- Have resided in Canada on August 24, 2020 and have remained in Canada since then;
- Have an active job offer;
- Submit an employer-specific work permit application no later than March 31st, 2021, supported by a Labor Market Impact Assessment (LMIA) or an LMIAexempt job offer;
- Meet all other standard eligibility criteria.

#### **GREEN INTERNSHIP PROGRAM-SCIENCE HORIZONS**

The **Science Horizons program** provides wage subsidies to eligible employers across Canada to enable them to hire recent college and university graduates for internships in the cleantech and environment sectors.

The Government of Canada is partnering with Science, Technology, Engineering and Mathematics (STEM) employers across Canada to create 900 green internship opportunities for students under the program.

Employers may receive up to \$15,000 in program funding for each intern they hire, and interns will have the opportunity to gain work experience on environmental projects lasting six to twelve months. About 90% of interns find full-time employment or return to school after their internship.

Program funding is targeted at employers in the environment and cleantech sectors.

#### THE CURVE: A PAN-CANADIAN PERSPECTIVE ON COVID-19

The National Film Board of Canada (NFB) has kicked off its online project **The Curve**, an ongoing account of the COVID-19 pandemic. This project brings together 40 talented artists who give a voice to a population affected by the pandemic. A collection of 30 works presents pan-Canadian perspectives from coast to coast, and as far as the Far North.

The episodes will follow one another throughout the season and will create a unique resource for anyone wishing to discover different stories about social distancing.

Three Northwest Studio short documentaries were the highlight of the official launch: In the Garden of the Farm by Kristin Catherwood, K'i Tah Amongst the Birch by Melaw Nakehk'o, and Thursday by Galen Johnson.

# SUPPORT FOR BUSINESSES AND ORGANIZATIONS

#### CANADA EMERGENCY BUSINESS ACCOUNT

The Canada Emergency Business Account (CEBA) provides interest-free loans of up to \$40,000 to small businesses and nonprofits impacted by the pandemic to help them cover their operation costs.

As the economic recovery continues, the CEBA has been **extended until October 31st**, 2020 so that Canadians can benefit from it longer.

In order to respond to businesses and organizations that have submitted an application, Export and Development Canada (EDC) has set up a new call centre. This way, applicants who have questions about the status of their application, the reasons why the request was refused, or the reasons why a submitted document was not accepted can dial **1-888-324-4201** for more information.

The call centre is open Monday through Friday, 8 a.m. to 9 p.m.

## **SECTORAL SUPPORT**

#### SECURING THE SUPPLY OF VACCINES AND TREATMENTS TO COMBAT COVID-19

The Government of Canada is working closely with researchers and scientists to better understand the COVID-19 virus and protect the health of Canadians. For example, the Government of Canada recently announced agreements in principle with Johnson & Johnson and Novavax to reserve millions of doses of experimental COVID-19 vaccines. These agreements are in addition to those already registered with Pfizer and Moderna.

The federal government will continue to negotiate and sign other similar agreements with a number of leading pharmaceutical companies to secure the supply of potential vaccines in Canada.

#### **ESTABLISHMENT OF NEW BIOFRABRICATION FACILITY**

The Government of Canada has announced funding to create a new biofabrication facility at the Human Health Therapeutics Research Center in Montreal. Through a public-private partnership, the new building will make it possible for the National Research Council of Canada (NRC) to scale up vaccine manufacturing to two million doses per month by next year.

This will help ensure our country's ability to produce enough vaccine doses for Canadians who need them, such as front-line workers, workers in long-term care facilities and those at risk of becoming seriously ill if they contract COVID-19.

Public health experts recommend that we:

- Limit our contact with other people by practicing social distancing;
- Frequently wash our hands for a minimum of 20 seconds;
- Use an alcohol-based sanitizer if we don't have access to water and soap;
